(as of March 2017)

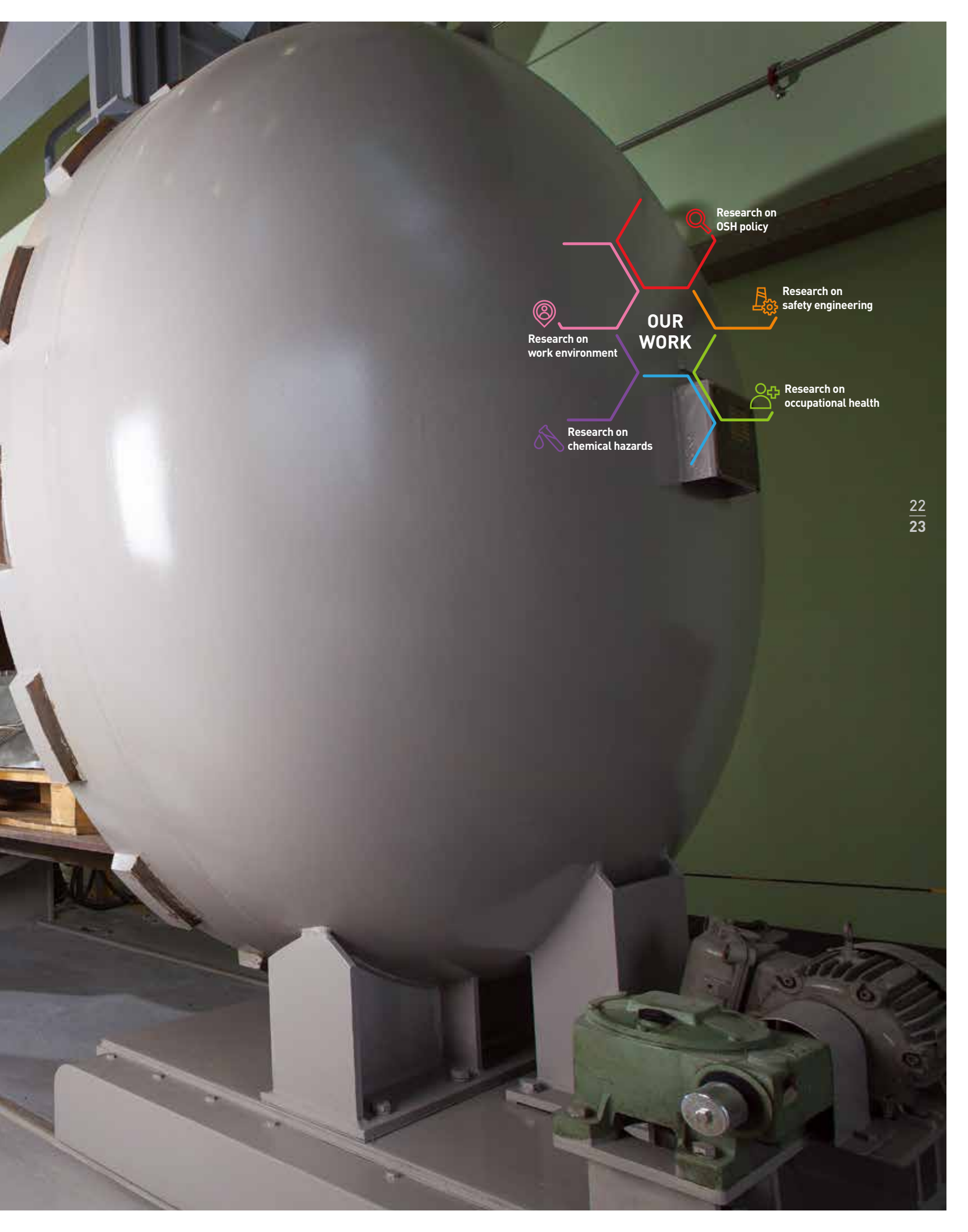

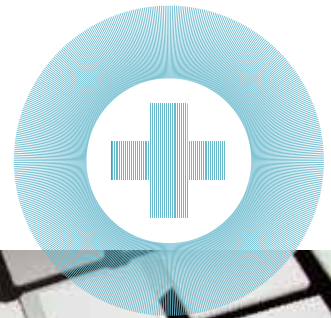
KOSHA takes R&D just as seriously as policy implementation and on-site inspection. With the nation's best OSH talents and state-of-art test labs, we are always looking for better ways to improve work environment, to understand chemical hazards, and most of all, to bring OSH in line with the actual needs of our workers.





Research on Safety Health and Safety Certification

In addition to research on industrial accidents prevention to analyze hazards and risk factors, KOSHA conducts specialized projects including safety certification of hazardous machinery/equipment and facilities, safety certification of protective gears and devices, epidemiologic investigation of occupational diseases, quality management of safety/health service organizations, hazards and risk assessment and management of chemicals, provision of information service, etc. in order to make sure all workers do their jobs safely at their workplace.



Research on Safety and Health Policies

Researches to develop legal, psychological, economical and social policies and improve the systems according to the labor environment changes, to provide solutions for social issues on safety and health and to discover safety and health policies for future industry.

Research on Examination and Assessment of Harms & Risks from Chemicals

Researches at the experimental animal research laboratory and inhalation toxicity research facility to identify harms from chemicals by conducting acute, subchronic and chronic inhalation toxicity and carcinogenicity tests and to find out harmfulness of chemicals with risks of fire or explosion, to protect workers from unidentified toxic substances.

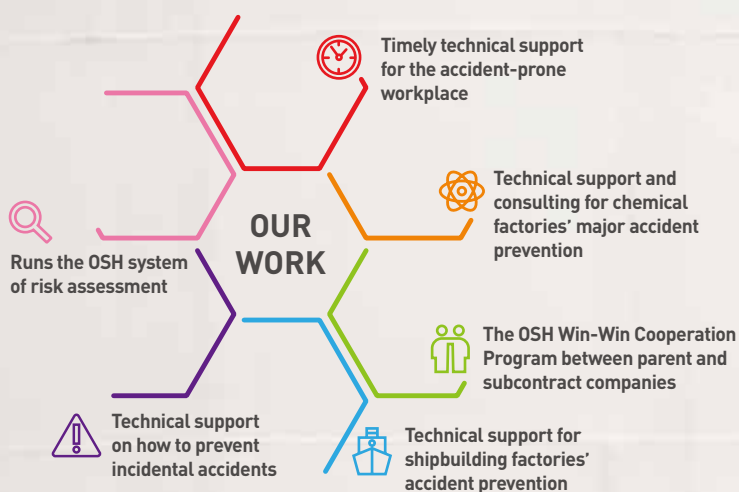

On-Site Technical Guidance and a Self-Regulatory OSH Management Support

In order to help create a safe and pleasant work environment, KOSHA is engaged in various activities that cater specifically to the needs of each workplace. We offer on-site technical guidance with a view that businesses, particularly those vulnerable to occupational accidents, can acquire a self-regulatory OSH management capability.



A System of Risk Assessment at Workplace

This is to help induce owners of manufacturing businesses (with less than 50 employees) to self-regulate and assess risk potential at their own workplace. Should they be recognized as an outstanding business in risk assessment by KOSHA, they receive a discount on their workers' compensation insurance premium.

Timely Technical Support for Accident-Prone Workplace

Should an accident occur in any workplace of the manufacturing, construction, service, transportation, storage, and communication industries, KOSHA provides technical support in a timely fashion in the way of analyzing its cause and suggesting a solution to prevent it in the future.

Technical Guidance for the OSH Win-Win Cooperation Program

The OSH Win-Win Cooperation Program allows both a parent company and its subcontractors to work together for workplace safety. According to this program, the former assists the latter in risk assessment, while KOSHA assists the latter in enhancing its OSH management capability.

Safety and Health Consulting when building a factory

We provide comprehensive SH consulting such as accident prevention techniques, educational training and materials by phase from establishing occupancy planning to the normal operation when building or relocating a factory.

Accept No Compromise on Safety At Our Construction Sites

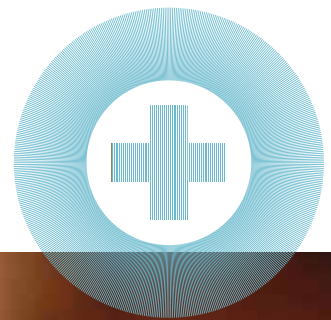
KOSHA offers safety support not only to minimize construction accidents across the board, but to create a work environment conducive to the self-regulatory OHS management. We target, in particular, construction sites vulnerable to major accidents and double our efforts to make them safe.





Technical Support to Ensure Safety ahead of Construction Work

To make sure all is safe before work begins, KOSHA reviews the Harm and Hazards Prevention Plan for approval and provides high-risk construction sites with technical support. To encourage self-regulatory OSH activities, KOSHA also offers consulting service on risk assessment and supports companies interested in building the OSH management system.



Safety and Health Guardians on Hire

Safety control is less than ideal at small and medium-sized construction sites (worth less than KRW 12 billion). KOSHA supports them by hiring and sending retired but experienced professionals as Safety and Health Guardians. They patrol the site they are in charge of on a constant basis. And they also act as safety consultants.

Doubled Assistance for Sites Prone to Major Accidents

We focus on high-risk sites where major accidents such as a collapse of form timbering or sheathing timbering. We assess each case and if necessary either supervise the work in question ourselves or ask a related company to do the job for us.

Supporting the OSH Relationship between Owner and Contractor


In cases of public works, KOSHA notifies the ordering public agency and the regional government involved of the construction accident rates and takes them into account when final assessment is written up. The contracted company's accident rates are publicly announced. On the other hand, KOSHA rewards companies engaged in accident prevention activities by giving them preferential benefits.



Share a Smile In a Safe Service

As the share of the service industry increased in Korea, its occupational accidents have also increased. In 2010, KOSHA created a new department exclusively devoted to preventing accidents in that industry and has since made every effort to make its workplaces safe. We will continue supporting those working individuals to smile as they go to work.

Basic Safety Support for Small Businesses

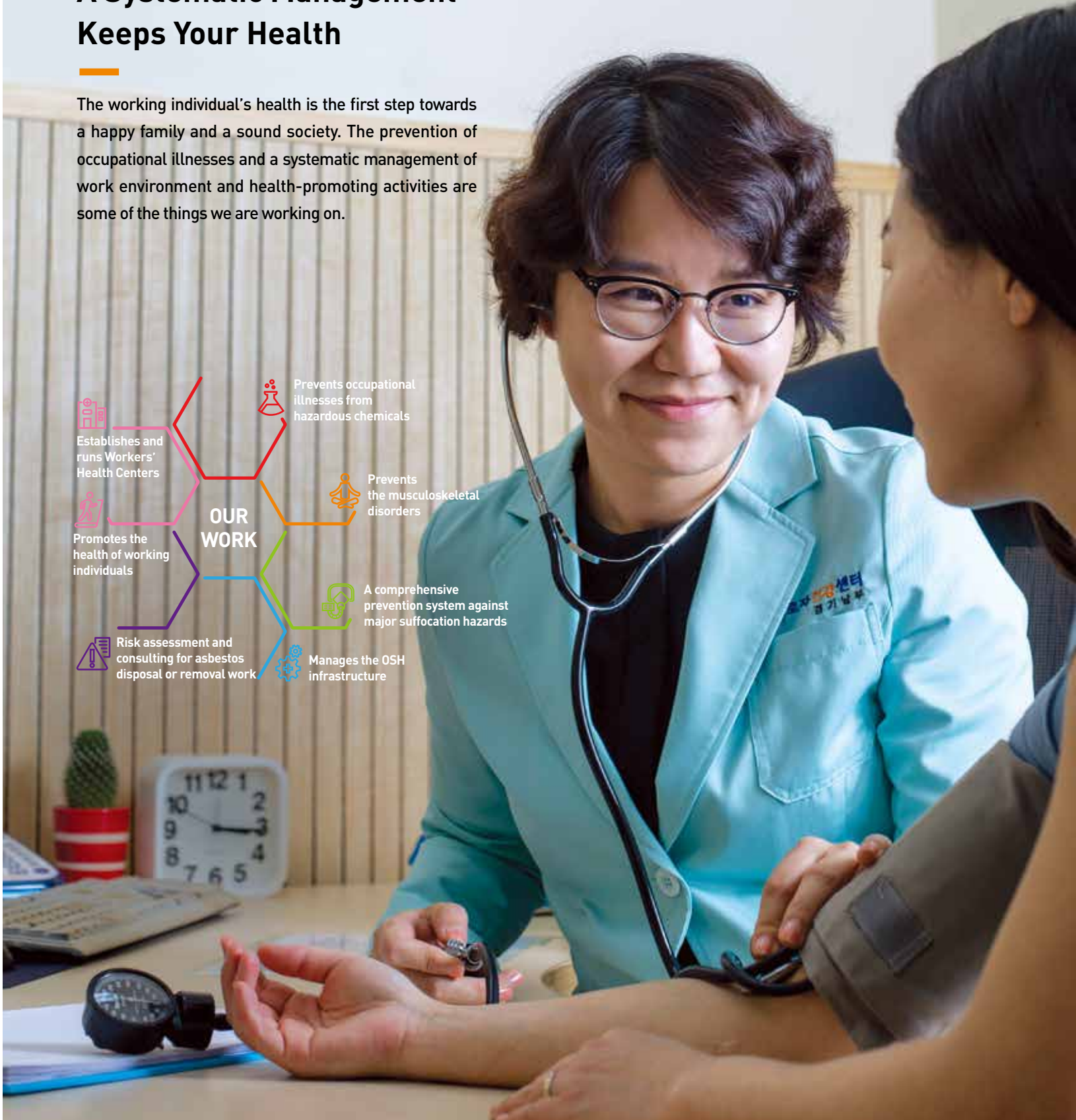

Preventing Occupational Diseases caused by Hazardous Substance

We strengthen our prevention activities of occupational diseases by providing technical support for a workplace where workers handle hazardous chemicals.

Revitalizing Health Promotion of Workers

We provide workers at a small-sized workplace with health care services by developing occupational health guidelines to find various job-related hazardous factors for health and present tailored measures and establishing/operating 26 nationwide Workers' Health Centers and the branch offices.

KOSHA takes a multi-faceted approach to MSDs: examine their job-related causes, improve work environment by taking ergonomics into account, manage them medically, and finally develop a manual of preventative measures.

Strengthening Health Protection of Emotional Laborers

We play a role as a professional organization by performing various activities such as developing public advertisements, campaigns, consulting, etc.





Financial Support

Financial Support To Make Your Workplace Clean

For small and medium-sized businesses, KOSHA runs the Clean Workplace Program and offers loans for occupational accident prevention facilities.



Grants and Loans for Small and Medium Businesses

Businesses with less than 50 employees may apply for a grant to remove harmful and hazardous factors from their construction site contracted under KRW 2 billion. Long-term, low-interest loans are also available to help them install occupational accident prevention facilities.

Subsidies for Workplace Monitoring & Medical Examinations

The Work Environment Monitoring Program and the Special Medical Examination are earmarked for small businesses where working individuals are exposed to potentially hazardous chemicals and dust.

Subsidy for Health-Promoting Activities

Intended for small and medium businesses, this program aims to help them keep away work-related diseases from their employees. KOSHA pays part of the cost.

KOSHA has developed a variety of educational programs that can be tailored to different needs; whether small and medium businesses in dire straits, those vulnerable to occupational accidents, or OSH personnel, we can all accommodate them.

The Owner's OSH Education Tied to Insurance Premium Discount

The point of the owner's education is to enable a self-regulatory accident prevention plan with an aid of risk assessment knowledge. Upon completing it, the owner is entitled to a discount in occupational accident insurance premium (provided that the business is in manufacturing and has less than 50 employees).

In-Depth Education at the OSH Training Institute

The OSH Training Institute runs the legally-mandated job education, a professional technique education, a long-distance learning by post, and e-learning.

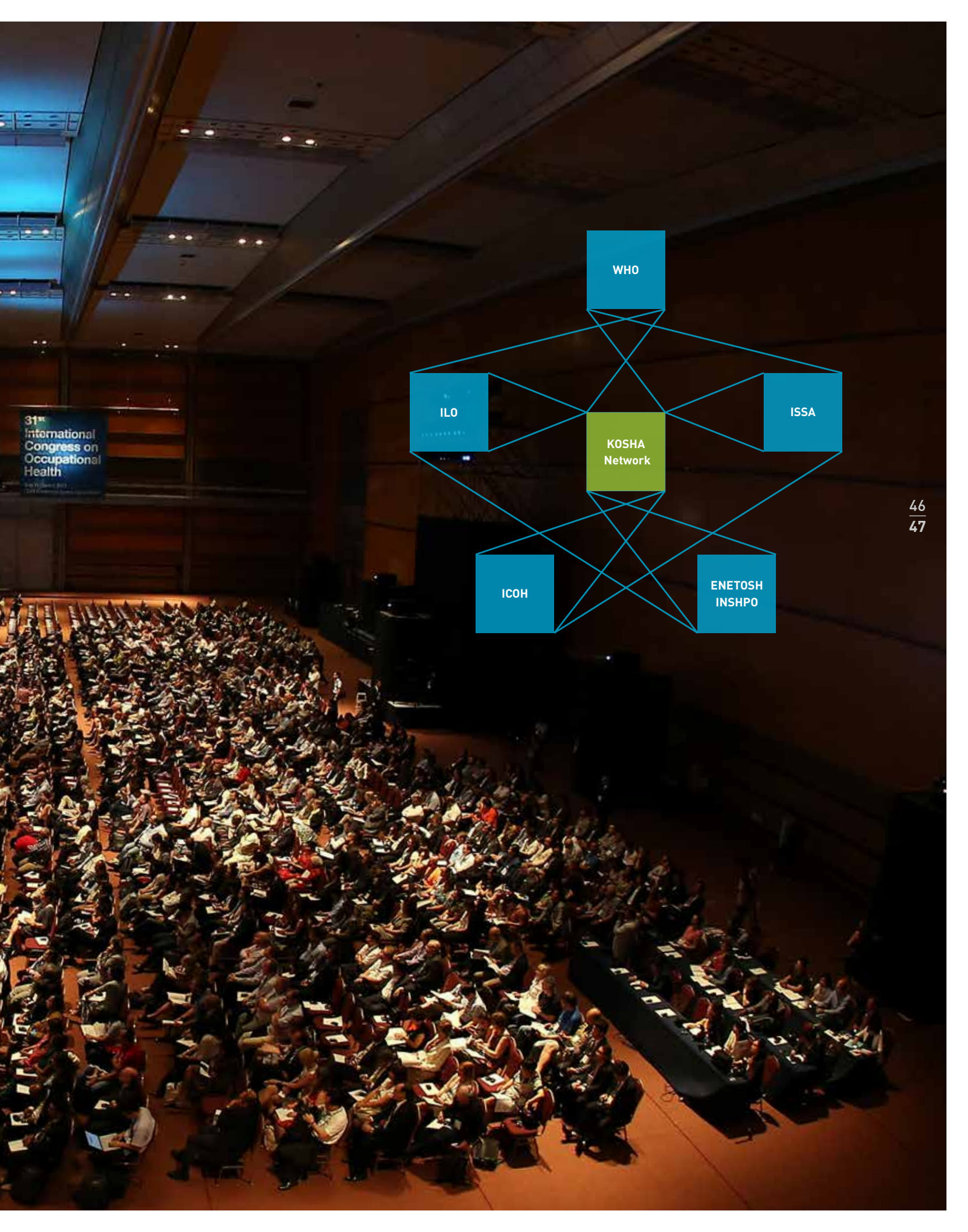

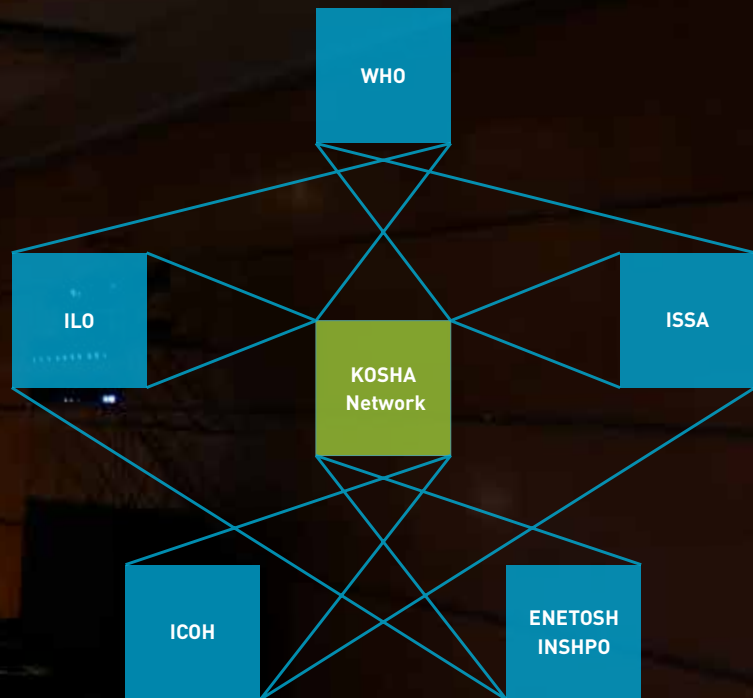
Achieve Safer and Happier Community through Global Cooperation

KOSHA conveys the message of safety through various media-broadcasting, publications, outdoor advertising, online, etc. We have also explored different genres of culture such as safety games and a play.

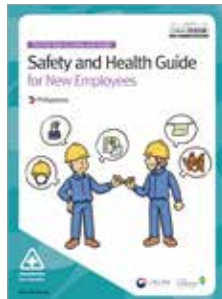
